- 2) **Durr's purchase order, job name or job number must appear on all documentation. Please enter in reference field 1 or 2.**
- 3) If applicable, packing list shall refer to purchase order line items.
- 4) The items mentioned above will assist in the receiving / **invoicing process**.
- 5) Dedicated loads should fill 70% of the truck at a minimum unless approved by Durr
- 6) It is suggested that we competitively bid overdimensional loads.
- 7) Supplier is responsible to generate customs invoice, tariff class, origin of manufacture for international shipments
- 8) **If the supplier deviates from these instructions without Durr approval, they may be responsible for freight charges**
